## Health Care Workplace Violence Prevention Act

This bill requires the Department of Labor to address workplace violence in health care facilities pursuant to the Occupational Safety and Health Act of 1970. Specifically, Labor must issue a rule that requires certain health care employers to adopt a comprehensive plan for protecting health care workers and other personnel from workplace violence.

## Actions Timeline

- **Mar 19, 2018:** Referred to the Subcommittee on Health.
- **Mar 9, 2018:** Referred to the Subcommittee on Health.
- **Mar 8, 2018:** Introduced in House
- **Mar 8, 2018:** Referred to the Committee on Education and the Workforce, and in addition to the Committees on Energy and Commerce, and Ways and Means, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
