Summary (as of Mar 14, 2018)

### Global Trade Accountability Act of 2018

This bill amends the Trade Act of 1974 to require congressional approval of unilateral trade actions. Such actions may take effect without congressional approval for one 90-day period if the President:

- determines that it is necessary because of a national emergency, because of an imminent threat to health or safety, for the enforcement of criminal laws, or for national security; and
- submits written notice of the determination to Congress.

### Actions Timeline

- **Mar 27, 2018:** Referred to the Subcommittee on Trade.
- **Mar 14, 2018:** Introduced in House
- **Mar 14, 2018:** Referred to the Committee on Ways and Means, and in addition to the Committee on Rules, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
