### Offshore Wind Jobs and Opportunity Act

This bill authorizes the Department of the Interior to award offshore wind career training grants to eligible entities (i.e., institutions of higher education or labor organizations) to develop, offer, or improve educational or career training programs that provide skills that are useful for employment in the offshore wind industry.

- **Mar 28, 2018:** Referred to the Subcommittee on Energy and Mineral Resources.
- **Mar 14, 2018:** Introduced in House
- **Mar 14, 2018:** Referred to the Committee on Natural Resources, and in addition to the Committee on Education and the Workforce, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
