## **CARA 2.0 Act of 2018**

This bill reauthorizes through FY2023 and revises several programs relating to opioid- and substance-use disorder prevention and treatment, including awareness campaigns and training programs for first responders; the bill also establishes several requirements relating to opioid prescribing practices, such as an initial three-day supply limit for certain opioids.

- **Apr 30, 2018:** Referred to the Subcommittee on Crime, Terrorism, Homeland Security, and Investigations.
- **Mar 16, 2018:** Referred to the Subcommittee on Health.
- **Mar 15, 2018:** Introduced in House
- **Mar 15, 2018:** Referred to the Committee on Energy and Commerce, and in addition to the Committees on the Judiciary, and Education and the Workforce, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
