Comprehensive Addiction Resources Emergency Act of 2018

This bill establishes a series of grant programs to assist localities with addressing the opioid epidemic, such as through prevention and treatment services, training centers, and research activities.

Actions Timeline

- **May 22, 2018:** Referred to the Subcommittee on Crime, Terrorism, Homeland Security, and Investigations.
- **Apr 26, 2018:** Referred to the Subcommittee on Indian, Insular and Alaska Native Affairs.
- **Apr 18, 2018:** Introduced in House
- **Apr 18, 2018:** Referred to the Committee on Energy and Commerce, and in addition to the Committees on the Judiciary, and Natural Resources, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
