#### National FFA Organization's Federal Charter Amendments Act

This bill revises the charter of the National FFA Organization (Future Farmers of America). Such revisions include (1) making it a purpose of the organization to be an integral component of agricultural, food, and natural resources education, and (2) removing the Secretary of Education as the chair of the National FFA Board of Directors.
