## Summary (as of Apr 26, 2018)

### Medical Cannabis Research Act of 2018

This bill amends the Controlled Substances Act to establish a new, separate registration process for manufacturers of cannabis for research.

The Drug Enforcement Administration must assess whether there is an adequate and uninterrupted supply of research cannabis and register additional manufacturers.

## Actions Timeline

- **Sep 13, 2018:** Ordered to be Reported (Amended) by Voice Vote.
- **May 22, 2018:** Referred to the Subcommittee on Crime, Terrorism, Homeland Security, and Investigations.
- **Apr 26, 2018:** Introduced in House
- **Apr 26, 2018:** Referred to the Committee on Energy and Commerce, and in addition to the Committees on the Judiciary, and Veterans' Affairs, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
- **Apr 26, 2018:** Referred to the Subcommittee on Health.
