Summary (as of May 21, 2018)

Coastal Texas Protection Act

This bill requires the U.S. Army Corps of Engineers to expedite the completion of the feasibility studies for flood damage reduction, hurricane and storm damage reduction, and ecosystem restoration in the coastal areas of Texas.

Actions Timeline

- **Jun 4, 2018:** Referred to the Subcommittee on Water, Power and Oceans.
- **May 22, 2018:** Referred to the Subcommittee on Water Resources and Environment.
- **May 21, 2018:** Introduced in House
- **May 21, 2018:** Referred to the Committee on Transportation and Infrastructure, and in addition to the Committee on Natural Resources, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
