## **Executive Branch Comprehensive Ethics Enforcement Act of 2018**

This bill expands the duties and authorities of the Office of Government Ethics (OGE).

Among other things, the bill authorizes the OGE to do the following:

- issue subpoenas during investigations; and
- order corrective actions (e.g., divestiture) and issue administrative remedies (e.g., suspension or demotion).

### **Actions Timeline**

---

- **Jul 24, 2018:** Referred to the Subcommittee on the Constitution and Civil Justice.
- **May 21, 2018:** Introduced in House
- **May 21, 2018:** Referred to the Committee on Oversight and Government Reform, and in addition to the Committee on the Judiciary, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
