#### Students Over Special Interests Act

This bill terminates the Tax Cuts and Jobs Act and forgives the outstanding balance of interest and principal due on federal student loans.

- **May 23, 2018:** Introduced in House
- **May 23, 2018:** Sponsor introductory remarks on measure. (CR H4592-4593)
- **May 23, 2018:** Referred to the Committee on Ways and Means, and in addition to the Committees on Education and the Workforce, Natural Resources, and Energy and Commerce, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
