## Summary (as of Jun 1, 2018)

### Common Sense Certification Reform Act

This bill prohibits the Occupational Safety and Health Administration from requiring the certification of employees for operating power-operated equipment (e.g., cranes) used in construction activities to deliver or retrieve propane containers.
