Reaffirms the special relationship between the United States and the United Kingdom.

Expresses respect for the decision of the June 23, 2016, referendum to leave the European Union and recognizes that it will not diminish the bond between the governments and people of the United States and the United Kingdom.

Supports bilateral and free trade discussions between the two countries.

Calls upon the U.S. Trade Representative to begin negotiations with the United Kingdom for a new U.S.-United Kingdom North Atlantic Trade and Investment Partnership.

Actions Timeline

- **Feb 16, 2017:** Referred to the Subcommittee on Europe, Eurasia, and Emerging Threats.
- **Jan 24, 2017:** Introduced in House
- **Jan 24, 2017:** Referred to the Committee on Foreign Affairs, and in addition to the Committee on Ways and Means, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
