Stretching Entity Resources for Vulnerable Communities Act or the SERV Communities Act

This bill makes a series of changes to the 340B drug pricing program (i.e., a program that allows entities to receive covered outpatient drugs at reduced prices from manufacturers), including alterations relating to program integrity, discrimination against participating entities, and program eligibility.

Actions Timeline

- **Jun 14, 2018:** Referred to the Subcommittee on Health.
- **Jun 12, 2018:** Introduced in House
- **Jun 12, 2018:** Referred to the Committee on Energy and Commerce, and in addition to the Committee on Ways and Means, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
