Summary (as of Jun 12, 2018)

Postal Reform Act of 2018

This bill makes several changes to the organization and policies of the U.S. Postal Service. The bill includes provisions regarding health and retirement benefits, governance and operations, closures and consolidations of post offices, personnel policies, and contracting authority.

Actions Timeline

- **Jun 18, 2018:** Referred to the Subcommittee on Health.
- **Jun 12, 2018:** Introduced in House
- **Jun 12, 2018:** Referred to the Committee on Oversight and Government Reform, and in addition to the Committees on Energy and Commerce, and Ways and Means, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
