State-Based Universal Health Care Act of 2018

This bill repeals and replaces existing Section 1332 waiver provisions under the Patient Protection and Affordable Care Act (also known as State Innovation Waivers) with waiver provisions that allow states to establish comprehensive universal health care plans, in accordance with specified requirements.

Actions Timeline

- **Oct 19, 2018:** Referred to the Subcommittee on Health, Employment, Labor, and Pensions.
- **Jun 19, 2018:** Referred to the Subcommittee on Health.
- **Jun 14, 2018:** Referred to the Subcommittee on Military Personnel.
- **Jun 13, 2018:** Introduced in House
- **Jun 13, 2018:** Referred to the Committee on Energy and Commerce, and in addition to the Committees on Ways and Means, Oversight and Government Reform, Armed Services, and Education and the Workforce, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
