## Summary (as of Jun 14, 2018)

### Preserving America's Battlefields Act

This bill reauthorizes through FY2028 the Battlefield Acquisition Grant Program and expands the purposes of the Civil War Battlefield Preservation Act of 2002. Specifically, the Act's purposes shall include:

- the preservation and protection of nationally significant battlefields of not only the Civil War but also the American Revolution and the War of 1812, and
- the enhancement of visitors' experiences at those battlefields.

### Actions Timeline

- **Dec 11, 2018:** Received in the Senate and Read twice and referred to the Committee on Energy and Natural Resources.
- **Dec 10, 2018:** Mr. Bishop (UT) moved to suspend the rules and pass the bill, as amended.

- **Dec 10, 2018:** DEBATE - The House proceeded with forty minutes of debate on H.R. 6108.
