Summary (as of Jun 19, 2018)

Know the Lowest Price Act of 2018

This bill prohibits a health-benefits plan or pharmacy-benefits manager under Medicare or Medicare Advantage from restricting a pharmacy from informing an enrollee of any difference between the price of a drug under the plan and the price of the drug without health-insurance coverage.

Actions Timeline

- **Jun 27, 2018:** Referred to the Subcommittee on Health.
- **Jun 19, 2018:** Introduced in House
- **Jun 19, 2018:** Referred to the Committee on Energy and Commerce, and in addition to the Committee on Ways and Means, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
