Summary (as of Jun 22, 2018)

Families First Act of 2018

This bill amends rules for the treatment of unaccompanied alien children and asylum-seeking families, and for detaining and removal of various types of aliens.

Actions Timeline

- **Aug 2, 2018:** Referred to the Subcommittee on Immigration and Border Security.
- **Jun 22, 2018:** Introduced in House
- **Jun 22, 2018:** Referred to the Committee on the Judiciary, and in addition to the Committee on Foreign Affairs, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
