Summary (as of Jun 27, 2018)

Social Security Administration Fairness Act

This bill (1) provides funding for certain administrative expenses of the Social Security Administration (SSA); (2) makes individuals eligible to receive Old Age, Survivors, and Disability Insurance (OASDI) benefits beginning in the first month of disability; (3) eliminates the Medicare waiting period for recipients of OASDI benefits; and (4) requires the SSA to satisfy certain public-notice and reporting requirements before closing or consolidating a field office or hearing office.

Actions Timeline

- **Jul 10, 2018:** Referred to the Subcommittee on Social Security.
- **Jun 27, 2018:** Introduced in House
- **Jun 27, 2018:** Referred to the Committee on Ways and Means, and in addition to the Committees on the Budget, Rules, and Energy and Commerce, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
