### Summary (as of Jun 27, 2018)

#### Congressional Access to Children's Detention Facilities Act

This bill requires the Department of Justice, the Department of Homeland Security, or the Department of Health and Human Services to allow Members of Congress to tour any facility in which one or more foreign national minors (a noncitizen of the United States under age 18) are housed. The Departments must allow members of the press to accompany a visiting Member of Congress and may place limits on such tours based on the number of foreign national minors housed.

### Actions Timeline

---

- **Aug 2, 2018:** Referred to the Subcommittee on Immigration and Border Security.
- **Jul 10, 2018:** Referred to the Subcommittee on Border and Maritime Security.
- **Jun 27, 2018:** Introduced in House
- **Jun 27, 2018:** Referred to the Committee on the Judiciary, and in addition to the Committee on Homeland Security, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
