Summary (as of Jul 24, 2018)

Marijuana Data Collection Act

This bill requires the Department of Health and Human Services, in coordination with the Department of Justice, the Department of Labor, and relevant state agencies, to enter into an arrangement with the National Academy of Sciences in order to study the effects of marijuana legalization in states that have legalized marijuana for medicinal or non-medicinal use.

Actions Timeline

- **Oct 1, 2018:** Referred to the Subcommittee on Crime, Terrorism, Homeland Security, and Investigations.
- **Jul 27, 2018:** Referred to the Subcommittee on Health.
- **Jul 24, 2018:** Introduced in House
- **Jul 24, 2018:** Referred to the Committee on Energy and Commerce, and in addition to the Committees on the Judiciary, and Education and the Workforce, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
