Summary (as of Jul 26, 2018)

Ban Nerve Agents In Our Food Act of 2018

This bill requires the Environmental Protection Agency (EPA) to cancel the registration of organophosphate pesticides under the Federal Insecticide, Fungicide, and Rodenticide Act.

The bill prohibits the sale and use of existing stock of organophosphate pesticides.

The bill requires the EPA to ban organophosphate pesticide residue on food under the Federal Food, Drug, and Cosmetic Act.

Actions Timeline

- **Sep 20, 2018:** Referred to the Subcommittee on Biotechnology, Horticulture, and Research.
- **Jul 27, 2018:** Referred to the Subcommittee on Environment.
- **Jul 26, 2018:** Introduced in House
- **Jul 26, 2018:** Referred to the Committee on Agriculture, and in addition to the Committee on Energy and Commerce, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
