Clean Slate Act of 2018

This bill requires courts to automatically seal records for certain arrests and nonviolent offenses involving marijuana. Additionally, the bill creates a mechanism to allow an individual to petition to seal criminal records for certain other nonviolent offenses.

- **Aug 14, 2018:** Introduced in House
- **Aug 14, 2018:** Referred to the House Committee on the Judiciary.
