115 S 3707	Related bill	Dec 5, 2018: Read twice and referred to the Committee on Homeland Security and Governmental Affairs.

This bill directs the Department of Homeland Security (DHS) to: (1) establish a policy applicable to individuals and entities that reports security vulnerabilities on DHS public websites, (2) develop a process for mitigation or remediation of security vulnerabilities that are reported, (3) consult with specified federal departments and nongovernmental security researchers in developing the policy, and (4) submit the policy and the remediation process to Congress. DHS must make such policy publicly available.

Actions Timeline

- **Sep 26, 2018:** Received in the Senate and Read twice and referred to the Committee on Homeland Security and Governmental Affairs.
- **Sep 25, 2018:** Reported (Amended) by the Committee on Homeland Security. H. Rept. 115-961.
- **Sep 25, 2018:** Placed on the Union Calendar, Calendar No. 749.
- **Sep 25, 2018:** Mr. McCaul moved to suspend the rules and pass the bill, as amended.
- **Sep 25, 2018:** Considered under suspension of the rules. (consideration: CR H8746-8748)
- **Sep 25, 2018:** DEBATE - The House proceeded with forty minutes of debate on H.R. 6735.
- **Sep 25, 2018:** At the conclusion of debate, the chair put the question on the motion to suspend the rules. Mr. McCaul objected to the vote on the grounds that a quorum was not present. Further proceedings on the motion were postponed. The point of no quorum was considered as withdrawn.
- **Sep 25, 2018:** Considered as unfinished business. (consideration: CR H8822)
- **Sep 25, 2018:** Passed/agreed to in House: On motion to suspend the rules and pass the bill, as amended Agreed to by voice vote.(text: CR H8746-8747)
