### Summary (as of Jan 20, 2018)

Waives a specified requirement of Rule XIII (Calendar and Committee Reports) to allow consideration of any resolution reported from the Committee on Rules through the legislative day of January 29, 2018, on the same day it is presented to the House.

Makes it in order at any time through the legislative day of January 28, 2018, for the Speaker of the House to suspend the rules.

- **Jan 20, 2018:** DEBATE - The House proceeded with one hour of debate on H. Res. 708.
- **Jan 20, 2018:** POINT OF ORDER - During the course of debate on H.Res. 708, exception was taken to certain words used and a demand was made to have words taken down. Subsequently, unanimous consent was granted to withdraw the words in question and debate continued under regular order.
- **Jan 20, 2018:** POINT OF ORDER - During the course of debate, exception was taken to the use of an exhibit used. The Chair viewed the exhibit and found that the exhibit did not constitute a breach of decorum.
- **Jan 20, 2018:** Mr. Perlmutter appealed the ruling of the chair. The question was then put on sustaining the ruling of the chair.
- **Jan 20, 2018:** Mr. Cole moved to table the motion to appeal the ruling of the chair
- **Jan 20, 2018:** On motion to table the motion to appeal the ruling of the chair Agreed to by recorded vote: 224 - 173, 2 Present (Roll no. 40).
- **Jan 20, 2018:** DEBATE - The House resumed with debate on H. Res. 708.
