- **Feb 2, 2017:** POSTPONED PROCEEDINGS - At the conclusion of debate on H.Res. 74, the Chair put the question on ordering the previous question and by voice vote, announced that the ayes had prevailed. Mr. Polis demanded the yeas and nays and the Chair postponed further proceedings on ordering the previous question until a time to be announced.
- **Feb 2, 2017:** Considered as unfinished business. (consideration: CR H893-894)
- **Feb 2, 2017:** On ordering the previous question Agreed to by the Yeas and Nays: 230 - 188 (Roll no. 74). (consideration: CR H893-894)
- **Feb 2, 2017:** Passed/agreed to in House: On agreeing to the resolution Agreed to by recorded vote: 232 - 190 (Roll no. 75).(text: CR H888)
- **Feb 2, 2017:** On agreeing to the resolution Agreed to by recorded vote: 232 - 190 (Roll no. 75). (text: CR H888)
- **Feb 2, 2017:** Motion to reconsider laid on the table Agreed to without objection.
- **Jan 31, 2017:** Introduced in House
- **Jan 31, 2017:** The House Committee on Rules reported an original measure, H. Rept. 115-8, by Mr. Cole.
- **Jan 31, 2017:** Both resolutions are closed to amendments. Both resolutions provides for one hour of general debate, and provide for one motion to recommit.
