Summary (as of Jan 30, 2017)

Rural Hospital Regulatory Relief Act of 2017

This bill amends title XVIII (Medicare) of the Social Security Act to permanently extend the application by the Centers for Medicare & Medicaid Services of an instruction against the enforcement of certain physician supervision requirements with respect to outpatient therapeutic services in critical access hospitals and small rural hospitals.

Actions Timeline

- **Feb 9, 2017:** Referred to the Subcommittee on Health.
- **Feb 3, 2017:** Referred to the Subcommittee on Health.
- **Jan 30, 2017:** Introduced in House
- **Jan 30, 2017:** Referred to the Committee on Energy and Commerce, and in addition to the Committee on Ways and Means, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
