### Summary (as of Feb 26, 2018)

Sets forth the rule for consideration of the bill (H.R. 1865) to amend the Communications Act of 1934 to clarify that section 230 of such Act does not prohibit the enforcement against providers and users of interactive computer services of Federal and State criminal and civil law relating to sexual exploitation of children or sex trafficking.

- **Feb 27, 2018:** DEBATE - The House proceeded with one hour of debate on H. Res. 748.
- **Feb 27, 2018:** POSTPONED PROCEEDINGS - At the conclusion of debate on H.Res. 748, the Chair put the question on ordering the previous question and by voice vote announced that the ayes had prevailed. Ms. Slaughter demanded the yeas and nays and the Chair postponed further proceedings on ordering the previous question until later in the legislative day.
- **Feb 27, 2018:** Considered as unfinished business. (consideration: CR H1287-1289)
- **Feb 27, 2018:** On ordering the previous question Agreed to by the Yeas and Nays: 228 - 184 (Roll no. 84).
- **Feb 27, 2018:** Passed/agreed to in House: On agreeing to the resolution Agreed to by recorded vote: 235 - 175 (Roll no. 85). (text: CR H1277)
- **Feb 27, 2018:** On agreeing to the resolution Agreed to by recorded vote: 235 - 175 (Roll no. 85). (text: CR H1277)
- **Feb 27, 2018:** Motion to reconsider laid on the table Agreed to without objection.
- **Feb 26, 2018:** Introduced in House
- **Feb 26, 2018:** The House Committee on Rules reported an original measure, H. Rept. 115-583, by Mr. Collins (GA).
- **Feb 26, 2018:** Rule provides for consideration of H.R. 1865 under a structured rule with one hour of debate equally divided and controlled by the Chair and Ranking Member of the Committee on the Judiciary. The rule makes in order an amendment in the nature of a substitute recommended by the Committee on the Judiciary printed in the bill. The rule also provides one motion to recommit with or without instructions.
- **Feb 26, 2018:** Placed on the House Calendar, Calendar No. 129.
