## Summary (as of Jul 28, 2017)

Expresses the sense of Congress regarding:

- elimination of homelessness by 2020;
- expanded funding for the low-income rental housing assistance program, the Community Development Block Grant program, the HOME Investment Partnerships program, the McKinney-Vento homeless assistance program, and the Low-Income Housing Tax Credit program;
- substantial additional funding to the National Housing Trust Fund;
- increased funding for job training and related programs;
- a federal "housing first" policy linking housing with supportive services for persons with special needs; and
- permanent housing connected to employment, transportation, and job training programs for American families and individuals.

## Actions Timeline

---

- **Jul 31, 2017:** Referred to the Subcommittee on Human Resources.
- **Jul 28, 2017:** Introduced in House
- **Jul 28, 2017:** Referred to the Committee on Financial Services, and in addition to the Committee on Ways and Means, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
