Protecting Seniors Access to Medicare Act

This bill amends the Patient Protection and Affordable Care Act (PPACA) to terminate the Independent Payment Advisory Board (IPAB). Under PPACA, the IPAB is tasked with developing proposals to reduce the per capita rate of growth in Medicare spending.

Actions Timeline

- **Nov 6, 2017:** Received in the Senate and Read twice and referred to the Committee on Finance.
- **Nov 2, 2017:** Rule H. Res. 600 passed House.
- **Nov 2, 2017:** Considered under the provisions of rule H. Res. 600. (consideration: CR H8413-8421)
