## Summary (as of Feb 7, 2017)

### Medicare Advantage Quality Payment Relief Act of 2017

This bill requires the Centers for Medicare & Medicaid Services to disregard the application of certain percentage quality increases when calculating the maximum payment that may be made to a Medicare Advantage organization.

## Actions Timeline

- **Feb 21, 2017:** Referred to the Subcommittee on Health.
- **Feb 10, 2017:** Referred to the Subcommittee on Health.
- **Feb 7, 2017:** Introduced in House
- **Feb 7, 2017:** Referred to the Committee on Ways and Means, and in addition to the Committee on Energy and Commerce, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
