### Summary (as of May 1, 2017)

#### Clean Ocean and Safe Tourism Anti-Drilling Act or the COAST Anti-Drilling Act

This bill amends the Outer Continental Shelf Lands Act to prohibit the Department of the Interior from issuing a lease or other authorization for the exploration, development, or production of oil, natural gas, or any other mineral in the Mid-Atlantic, South Atlantic, North Atlantic, or the Straits of Florida planning areas.

- May 1, 2017: Introduced in Senate
- May 1, 2017: Read twice and referred to the Committee on Energy and Natural Resources.
