## **SFC Sean Cooley and SPC Christopher Horton Congressional Gold Star Family Fellowship Program Act**

This resolution establishes in the House of Representatives the Congressional Gold Star Family Fellowship Program under which certain family members of deceased members of the Armed Forces or deceased veterans may serve a 12-month fellowship in the office of a Member of the House.

### **Actions Timeline**

- **Oct 29, 2019:** Ms. Lofgren moved to suspend the rules and agree to the resolution, as amended.
- **Oct 29, 2019:** Considered under suspension of the rules. (consideration: CR H8580-8583)
- **Oct 29, 2019:** DEBATE - The House proceeded with forty minutes of debate on H. Res. 107.
- **Oct 29, 2019:** At the conclusion of debate, the chair put the question on the motion to suspend the rules. Mr. Davis, Rodney objected to the vote on the grounds that a quorum was not present. Further proceedings on the motion were postponed. The point of no quorum was considered as withdrawn.
