Summary (as of Feb 8, 2019)

Indian Programs Advanced Appropriations Act

This bill authorizes advance appropriations for several covered appropriations accounts of (1) the Bureau of Indian Affairs and Bureau of Indian Education within the Department of the Interior, and (2) the Indian Health Service within the Department of Health and Human Services. The advance appropriations provide new budget authority that first becomes available for the first fiscal year after the budget year.

The covered accounts within the Bureau of Indian Affairs and Bureau of Indian Education include (1) Operation of Indian Programs, (2) Contract Support Costs, and (3) the Indian Guaranteed Loan Program Account.

The covered accounts within the Indian Health Service include (1) Indian Health Services, and (2) Contract Support Costs.

The bill also requires the President's budget and the supporting documents submitted to Congress to include detailed estimates related to the advance appropriations.

Actions Timeline

- **Sep 25, 2019:** Subcommittee Hearings Held.
- **Feb 28, 2019:** Referred to the Subcommittee for Indigenous Peoples of the United States.
- **Feb 8, 2019:** Introduced in House
- **Feb 8, 2019:** Referred to the Committee on the Budget, and in addition to the Committees on Natural Resources, and Energy and Commerce, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
