## Summary (as of Jan 15, 2019)

### All-American Flag Act

This bill prohibits agencies from using funds to procure a U.S. flag unless such flag has been manufactured in the United States from materials that have been U.S. grown, produced, or manufactured. The bill specifies exceptions to this prohibition, including an exception if flags of satisfactory quality and sufficient quantity cannot be procured as needed at market prices.

## Actions Timeline

- **Jan 16, 2019:** Received in the Senate and Read twice and referred to the Committee on Homeland Security and Governmental Affairs.
- **Jan 15, 2019:** Mr. Cummings moved to suspend the rules and pass the bill.
- **Jan 15, 2019:** Considered under suspension of the rules. (consideration: CR H566-567)
- **Jan 15, 2019:** DEBATE - The House proceeded with forty minutes of debate on H.R. 113.
- **Jan 15, 2019:** Passed/agreed to in House: On motion to suspend the rules and pass the bill Agreed to by voice vote.(text: CR H566)
- **Jan 15, 2019:** On motion to suspend the rules and pass the bill Agreed to by voice vote. (text: CR H566)
