Summary (as of Feb 13, 2019)

Protecting Disaster Relief Funds Act of 2019

This bill protects certain funds already appropriated for disaster relief or recovery from being transferred to the planning or construction of a new physical barrier along the southwest border of the United States. Specifically, the bill prohibits the transfer of certain funds appropriated to the Department of Homeland Security, the Department of Housing and Urban Development, and the U.S. Army Corps of Engineers.

Actions Timeline

- **Feb 14, 2019:** Referred to the Subcommittee on Economic Development, Public Buildings, and Emergency Management.
- **Feb 13, 2019:** Introduced in House
- **Feb 13, 2019:** Referred to the Committee on Transportation and Infrastructure, and in addition to the Committee on Financial Services, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
