Summary (as of Oct 27, 2020)

Commitment to American Security Act

This bill enacts specified legislation related to law enforcement and national security, including legislation (1) allowing a qualified individual to carry a concealed handgun into or possess a concealed handgun in another state that allows individuals to carry concealed firearms; and (2) containing provisions related to border security, cybersecurity, and transportation security.

Actions Timeline

- **Oct 28, 2020:** Referred to the Subcommittee on Aviation.
- **Oct 27, 2020:** Introduced in House
- **Oct 27, 2020:** Referred to the Committee on Homeland Security, and in addition to the Committees on the Judiciary, Foreign Affairs, Ways and Means, Oversight and Reform, Energy and Commerce, and Transportation and Infrastructure, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
