#### **Mental Health Telemedicine Expansion Act**

This bill excludes certain mental health telehealth services from specified requirements under Medicare, including originating site requirements.

### Actions Timeline

- **Feb 19, 2019:** Referred to the Subcommittee on Health.
- **Feb 15, 2019:** Introduced in House
- **Feb 15, 2019:** Referred to the Committee on Energy and Commerce, and in addition to the Committee on Ways and Means, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
- **Feb 15, 2019:** Referred to the Subcommittee on Health.
