Summary (as of Apr 8, 2019)

Local Water Protection Act

This bill reauthorizes through FY2024 grants to states for (1) programs that manage and control pollution added from nonpoint sources to navigable waters, and (2) groundwater quality protection activities to advance state implementation of such programs. Water pollution from nonpoint sources is caused by precipitation picking up pollution as it moves over or through the ground.

- **Apr 9, 2019:** Received in the Senate and Read twice and referred to the Committee on Environment and Public Works.
- **Apr 8, 2019:** Reported by the Committee on Transportation and Infrastructure. H. Rept. 116-36.

- **Apr 8, 2019:** Mrs. Craig moved to suspend the rules and pass the bill.
- **Apr 8, 2019:** DEBATE - The House proceeded with forty minutes of debate on H.R. 1331.
