Summary (as of Mar 11, 2019)

FinCEN Improvement Act of 2019

This bill amends the duties of the Financial Crimes Enforcement Network (FinCEN). FinCEN must work with tribal law enforcement agencies, protect against terrorism regardless of origin, and coordinate internationally on matters involving emerging technology and virtual currency.

Actions Timeline

- **Mar 12, 2019:** Received in the Senate and Read twice and referred to the Committee on Banking, Housing, and Urban Affairs.
- **Mar 11, 2019:** Ms. Waters moved to suspend the rules and pass the bill.
- **Mar 11, 2019:** Considered under suspension of the rules. (consideration: CR H2621-2623)
- **Mar 11, 2019:** DEBATE - The House proceeded with forty minutes of debate on H.R. 1414.
- **Mar 11, 2019:** Passed/agreed to in House: On motion to suspend the rules and pass the bill Agreed to by voice vote.(text: CR H2621-2622)
- **Mar 11, 2019:** On motion to suspend the rules and pass the bill Agreed to by voice vote. (text: CR H2621-2622)
- **Mar 11, 2019:** Motion to reconsider laid on the table Agreed to without objection.
- **Feb 27, 2019:** Introduced in House
- **Feb 27, 2019:** Referred to the House Committee on Financial Services.
