Mr. Woodall demanded the yeas and nays and the Chair postponed further proceedings on ordering the previous question until a time to be announced.

- **Feb 25, 2019:** Rule provides for consideration of H.J. Res. 46 with 1 hour of general debate. Previous question shall be considered as ordered without intervening motions except motion to recommit with or without instructions. Measure will be considered read. Bill is closed to amendments.
- **Feb 25, 2019:** Placed on the House Calendar, Calendar No. 9.
