This resolution recognizes that the national debt is a threat to national security and that deficits are unsustainable, irresponsible, and dangerous. It also commits to restoring regular order to the appropriations process and addressing the fiscal crisis faced by the United States.

## Actions Timeline

- **Feb 26, 2019:** Introduced in House
- **Feb 26, 2019:** Sponsor introductory remarks on measure. (CR H2224-2225)
- **Feb 26, 2019:** Referred to the Committee on the Budget, and in addition to the Committee on Ways and Means, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
- **Feb 26, 2019:** Referred to the Subcommittee on Social Security.
