## Summary (as of Mar 5, 2019)

### Stopping Appealing Flavors in E-Cigarettes for Kids Act or the SAFE Kids Act

This bill generally prohibits the inclusion of flavored products in non-cigarette tobacco products, including electronic nicotine delivery system (e.g., e-cigarettes and vape pens).
