### Marijuana Data Collection Act

This bill requires the Department of Health and Human Services, in coordination with the Department of Justice, the Department of Labor, and relevant state agencies, to enter into an arrangement with the National Academy of Sciences in order to study the effects of marijuana legalization in states for medicinal or non-medicinal use.

### Actions Timeline

---

- **Apr 8, 2019:** Referred to the Subcommittee on Crime, Terrorism, and Homeland Security.
- **Mar 8, 2019:** Referred to the Subcommittee on Health.
- **Mar 7, 2019:** Introduced in House
- **Mar 7, 2019:** Referred to the Committee on Energy and Commerce, and in addition to the Committees on the Judiciary, and Education and Labor, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
