## Summary (as of Mar 26, 2019)

### Menstrual Equity For All Act of 2019

This bill expands specified programs to include access to menstrual hygiene products. Specifically, the bill requires that such products are made available to (1) public school students, (2) incarcerated or detained individuals, (2) homeless individuals, (3) individuals using health care flexible-spending accounts, (4) Medicaid recipients; (5) employees of organizations with at least 100 workers, and (6) individuals accessing federal buildings.

- **Mar 27, 2019:** Referred to the Subcommittee on Health.
- **Mar 26, 2019:** Introduced in House
- **Mar 26, 2019:** Sponsor introductory remarks on measure. (CR E355)
- **Mar 26, 2019:** Referred to the Committee on Education and Labor, and in addition to the Committees on the Judiciary, Financial Services, Ways and Means, Energy and Commerce, and Transportation and Infrastructure, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
