#### Cybersecurity Advisory Committee Authorization Act of 2019

This bill requires the Department of Homeland Security to establish a cybersecurity advisory committee within the Cybersecurity and Infrastructure Security Agency (CISA) to consult on the development, refinement, and implementation of policies, programs, and security directives pertinent to the mission of CISA.

- **Mar 29, 2019:** Referred to the Subcommittee on Energy.
- **Mar 28, 2019:** Introduced in House
- **Mar 28, 2019:** Referred to the Committee on Homeland Security, and in addition to the Committees on Energy and Commerce, and Oversight and Reform, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
