## **Strengthening the Tenth Amendment Through Entrusting States Act or the STATES Act**

This bill eliminates regulatory controls and administrative, civil, and criminal penalties under the Controlled Substances Act for certain marijuana-related activities that comply with state or tribal law.

The bill also requires the Government Accountability Office to study and report on the effects of marijuana legalization on traffic safety.

- **Apr 5, 2019:** Referred to the Subcommittee on Highways and Transit.
- **Apr 5, 2019:** Referred to the Subcommittee on Health.
- **Apr 4, 2019:** Introduced in House
- **Apr 4, 2019:** Referred to the Committee on the Judiciary, and in addition to the Committees on Energy and Commerce, and Transportation and Infrastructure, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
