## **Consolidated Appropriations Act, 2019**

This bill provides FY2019 appropriations for several federal departments and agencies. It includes 6 of the 12 regular FY2019 appropriations bills:

- the Department of the Interior, Environment, and Related Agencies Appropriations Act, 2019;
- the Financial Services and General Government Appropriations Act, 2019;
- the Agriculture, Rural Development, Food and Drug Administration, and Related Agencies Appropriations Act, 2019;
- the Transportation, Housing and Urban Development, and Related Agencies Appropriations Act, 2019;
- the Commerce, Justice, Science, and Related Agencies Appropriations Act, 2019; and
- the Department of State, Foreign Operations, and Related Programs Appropriations Act, 2019.

The departments and agencies funded in the bill include

- the Department of the Interior;
- the Environmental Protection Agency;
- the Forest Service;
- the Department of the Treasury,
- the judiciary;
- the Executive Office of the President;
- the District of Columbia;
- the Department of Agriculture;
- the Food and Drug Administration;
- the Department of Transportation;
- the Department of Housing and Urban Development;
- the Department of Commerce;
- the Department of Justice;
- science-related agencies, including the National Aeronautics and Space Administration (NASA);
- the Department of State; and
- several related and independent agencies.

The bill also extends several authorities and programs, including

- the National Flood Insurance Program,
- the authority for the Environmental Protection Agency to collect and spend certain fees related to pesticides,
- the Temporary Assistance for Needy Families (TANF) program, and
- several Medicaid provisions.

## Actions Timeline

- **Jan 4, 2019:** Received in the Senate. Read the first time. Placed on Senate Legislative Calendar under Read the First Time.
- **Jan 3, 2019:** Introduced in House
- **Jan 3, 2019:** Referred to the Committee on Appropriations, and in addition to the Committee on the Budget, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
- **Jan 3, 2019:** Committee on Appropriations discharged.
- **Jan 3, 2019:** Committee on the Budget discharged.
- **Jan 3, 2019:** Considered under the provisions of rule H. Res. 5. (consideration: CR H32-190)
- **Jan 3, 2019:** DEBATE - The House proceeded with one hour of debate on H.R. 21.
- **Jan 3, 2019:** The previous question was ordered pursuant to the rule.
- **Jan 3, 2019:** Ms. Granger moved to recommit with instructions to the Committee on Appropriations. (text: CR H189)
- **Jan 3, 2019:** DEBATE - The House proceeded with 10 minutes of debate on the Granger motion to recommit with instructions. The instructions contained in the motion seek to require the bill to be reported back to the House with an amendment to strike section 7071 from the bill.
- **Jan 3, 2019:** The previous question on the motion to recommit with instructions was ordered without objection.
- **Jan 3, 2019:** POSTPONED PROCEEDINGS - At the conclusion of debate on the motion to recommit with instructions, the Chair put the question on the motion and by voice vote, announced that the noes had prevailed. Mrs. Granger demanded the yeas and nays and the Chair postponed further consideration on the motion to recommit until a time to be announced.
