PFAS Registry Act of 2019

This bill directs the Department of Veterans Affairs to establish a registry for current or past members of the Armed Forces who may have been exposed to per- and polyfluoroalkyl substances due to the environmental release of aqueous film-forming foam at a military installation or other Department of Defense location.

Actions Timeline

- **Apr 29, 2019:** Referred to the Subcommittee on Health.
- **Apr 29, 2019:** Referred to the Subcommittee on Disability Assistance and Memorial Affairs.
- **Apr 11, 2019:** Referred to the Subcommittee on Military Personnel.
- **Apr 10, 2019:** Introduced in House
- **Apr 10, 2019:** Referred to the Committee on Veterans' Affairs, and in addition to the Committee on Armed Services, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
