Brand USA Extension Act

This bill (1) extends funding for Brand USA, the Corporation for Travel Promotion, through FY2027; (2) raises the fee for using the electronic system for travel authorization; and (3) otherwise modifies the duties and powers of Brand USA.

Actions Timeline

- **Oct 1, 2020:** Committee on Commerce, Science, and Transportation. Reported by Senator Wicker with amendments. With written report No. 116-275.
- **Oct 1, 2020:** Placed on Senate Legislative Calendar under General Orders. Calendar No. 568.
- **Jul 24, 2019:** Committee on Commerce, Science, and Transportation. Ordered to be reported with amendments favorably.
- **Jul 23, 2019:** Introduced in Senate
- **Jul 23, 2019:** Read twice and referred to the Committee on Commerce, Science, and Transportation.
